



**THE CITY OF SAN JACINTO 4TH OF JULY PARADE
Participant's Release and Waiver of Liability and Assumption of Risk Agreement**

In consideration of permitting me to participate in the 4th of July Parade sponsored by the City of San Jacinto, I hereby voluntarily release, discharge and hold harmless the City of San Jacinto, the Redevelopment Agency of the City of San Jacinto, the California Highway Patrol, the California Department of Transportation, their elected officials, officers, employees, agents, and volunteers from any liability for personal injury, property damage or wrongful death occurring to me as a result of participating in the parade or any activities incidental thereto including travel to and from the site of the parade, wherever or however the same may occur. I do this on behalf of myself and my heirs, executors, administrators, and assigns.

I hereby acknowledge that there exists risks of harm associated with the participation of a parade which may give rise to bodily injury, death and/or property damage. These risks include, but are not limited to, exposure to heat, exhaustion, dehydration, noise, fireworks, and/or contact with animals, spectators, flying objects, floats, vehicles, and crowds. I knowingly and voluntarily assume full responsibility for any such risks arising out of or related to my participation in the parade. I further agree that under no circumstances will I or my executors, heirs administrators or assigned prosecute or present any claim for personal injury, property damage or wrongful death against the City of San Jacinto, the Redevelopment Agency of the City of San Jacinto, the California Highway Patrol, the California Department of Transportation, their elected officials, officers, employees, agents, and volunteers for any cause of action, whether the same shall arise by the active or passive negligence of any persons, or otherwise. I knowingly and voluntarily give up valuable legal rights, including the right to sue.

I hereby understand that due to insurance limitations imposed upon the City of San Jacinto, I must hold my own liability insurance policy covering any animals (horses, cows, oxen, etc.) used during the parade and any damages that may occur due to my participation in the parade.

I understand that the City of San Jacinto also reserves the right to assist in orderly line-up announcing, and tradition.

I acknowledge that I have read the foregoing, fully understand and am fully aware of the consequences of signing the document. I also acknowledge that I have read the attached *Guidelines for the City of San Jacinto 4th of July Parade* and agree to comply with them.
